**RECONVENED TOWN BOARD MEETING & BUDGET WORK-SESSION**

Supervisor Rieber Reconvened the 10/20/2016 Budget Work-Session at 5:12 PM for the purpose of continuing discussion and review of the 2017 Fiscal-Year Tentative Budget. Town Clerk Marilee J. Calhoun advised that notification of this meeting and budget work-session was provided at the 10/20/2016 Recessed Town Board Meeting and Budget Work-Session and posted on the Town Hall bulletin board.

**BUDGET WORK-SESSION**

The Town Board continued discussing and reviewing the 2017 Fiscal-Year Tentative Budget. Comptroller Lasher provided the Town Board with a newly printed budget report of the proposed changes that have been made as previously directed from the prior budget work-sessions. The Town Board met with Assessor Van B. Krzywicki to discuss the Assessor's Budget, Town Clerk Marilee J. Calhoun to discuss the Town Clerk and Registrar Budgets and Director James Carnell, Jr. to discuss the Building, Planning and Zoning Department Budgets. The Town Board reviewed and discussed the individual Department Budget Requests as follows:

Assessor's Office, Town Clerk/Registrar, Building, Planning and Zoning, Highway DA, Highway DB, Adelaar Road Improvement District, Dog Control, Town Board, Supervisor, Town Attorney's, Tax Collector and Comptroller.

Comptroller Lasher will make all of the requested changes to the Tentative Budget and will present the revised copy to the Board at the next Budget Work-Session.

The Board agreed to recess this meeting until Wednesday, October 26<sup>th</sup>, 2016 at 5PM to continue the Budget Work-Session to discuss the Justice Court Budget and accept the Tentative Budget as amended including any last minute changes, which is filed as the Preliminary Budget with the Town Clerk.
